- 7. Eligibility: Employees, officials, and immediate family members of Chevron Federal Credit Union are not eligible to participate in the Sweepstakes. To qualify for the Sweepstakes, all entrants must be at least 18 years of age and reside within the U.S. By entering this Sweepstakes, entrants accept and agree to be bound by these Official Rules and the decisions of the Credit Union. Sweepstakes void where prohibited by law.
- 8. Sweepstakes Entries: One entry per person per promotional period.

Automatic Entry:

To receive an automatic entry to the sweepstakes, current Chevron Federal Credit Union members in good standing may visit the Credit Union's "Refer-a-Member" webpage at https://chevronfcu.org/may-referral and complete the new member referral form.

New members who open a Primary Share Savings Account during the Sweepstakes entry period with a minimum deposit amount of at least \$25 will receive an automatic entry. New members do not need to be referred to be entered. Current members who open additional memberships during the sweepstakes period will not receive an entry.

Alternate Method of Entry:

Write-in entries must contain all entry fields outlined above; otherwise, they are void and will not be eligible to win.

Entries using macro, robotic, script or other forms of automatic entry will be disqualified. Proof of submission does not constitute proof of receipt. The Credit Union is not responsible for late, incomplete, or inaccurate entries. The Credit Union reserves the right to select winners from eligible entries received as of such termination date. The Credit Union further reserves the right to disqualify any individual who tampers with the entry process.
